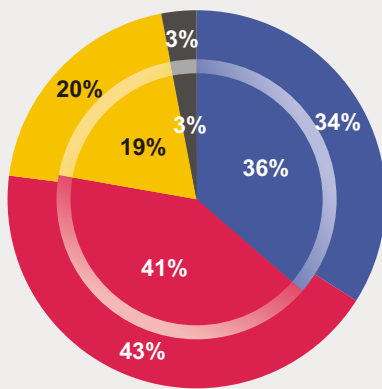

**QUESTION:** At the present time, would you say that, in general, things are going in the right direction or in the wrong direction, in...?

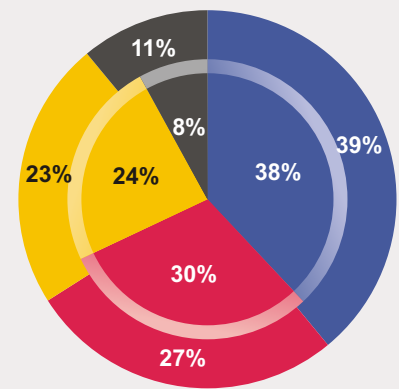
Pie chart answers: Our Country

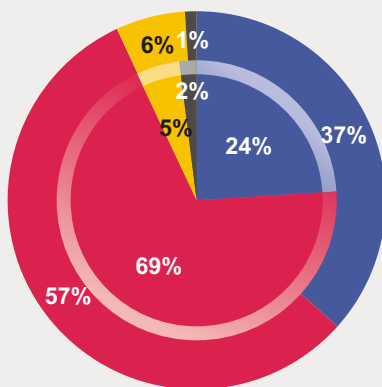
Pie chart answers: European Union

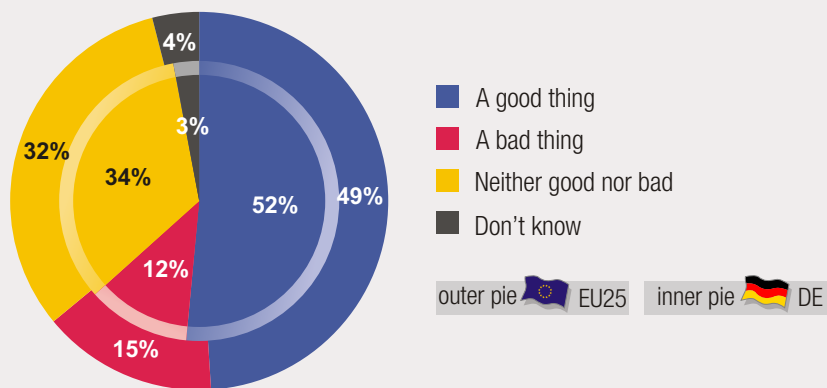

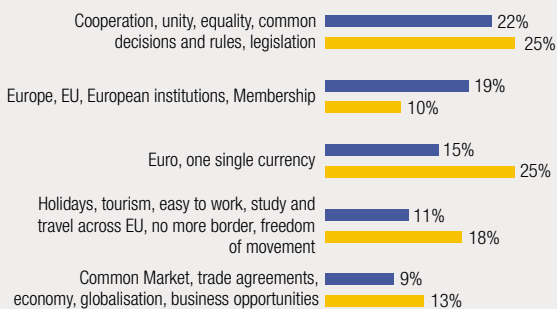
### Membership of the European Union

**QUESTION:** Generally speaking, do you think that (OUR COUNTRY)'s membership of the European Union is...?



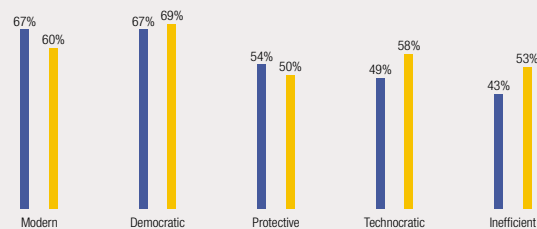
### Spontaneous Mentions of the Words 'European Union'

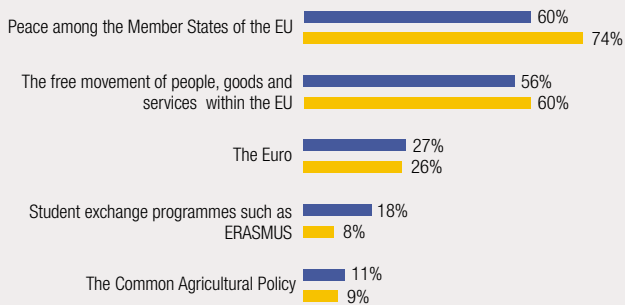

**QUESTION:** Which of the following do you think is the most positive result of European unification? And the second most positive result?

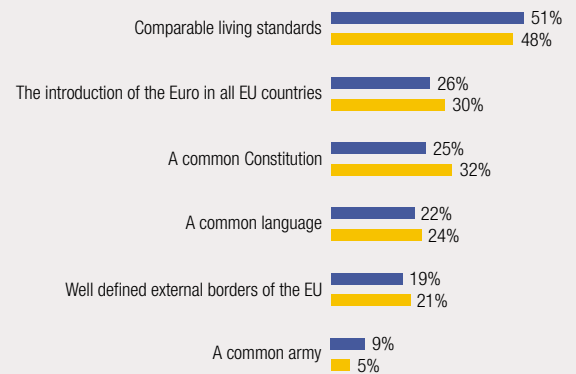


Graph answers: Total "First and second positive results"



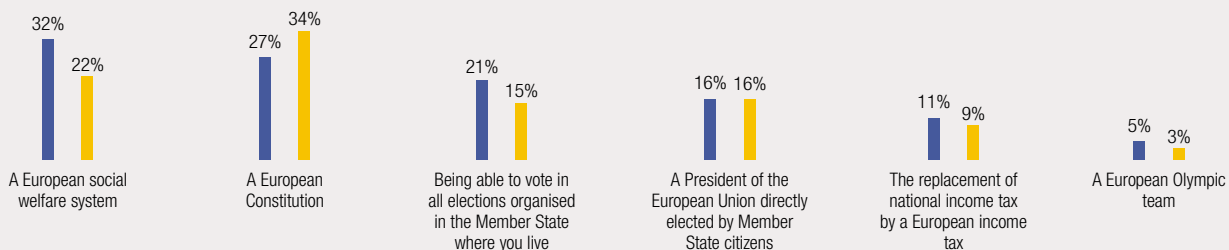
### Most Helpful Thing for the Future of Europe

### How to Strengthen European Identity?

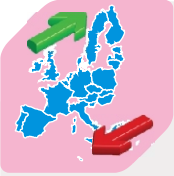

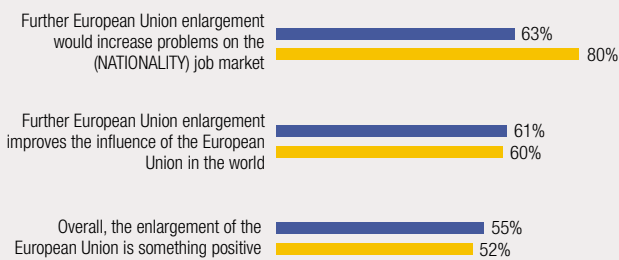

**QUESTION:** Could you tell me to what extent you agree or disagree with each of the following statements.

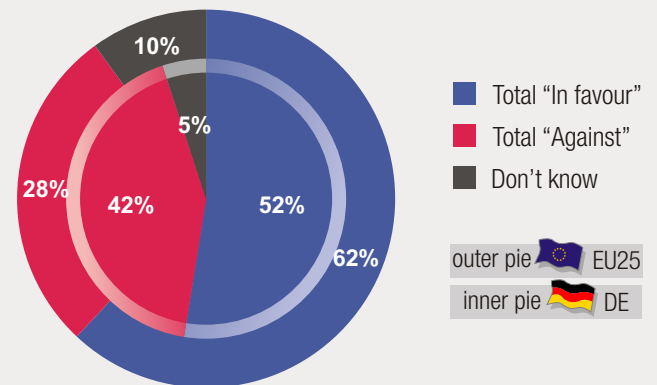

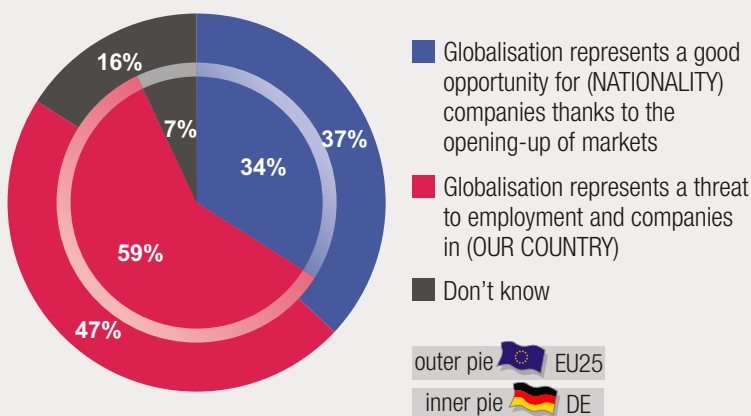
### Harmonization of Social Welfare Systems in the European Union

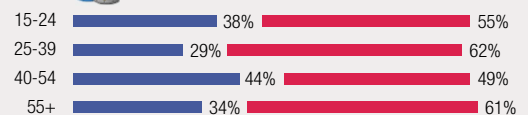
### Attitudes Towards Globalisation

**QUESTION:** Which of the following two propositions is the one which is closest to your opinion with regard to globalisation?

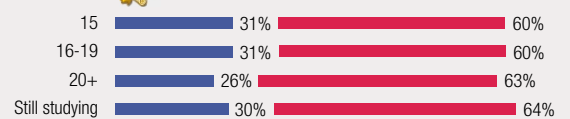

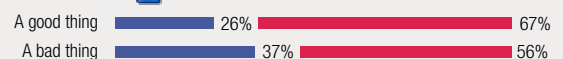

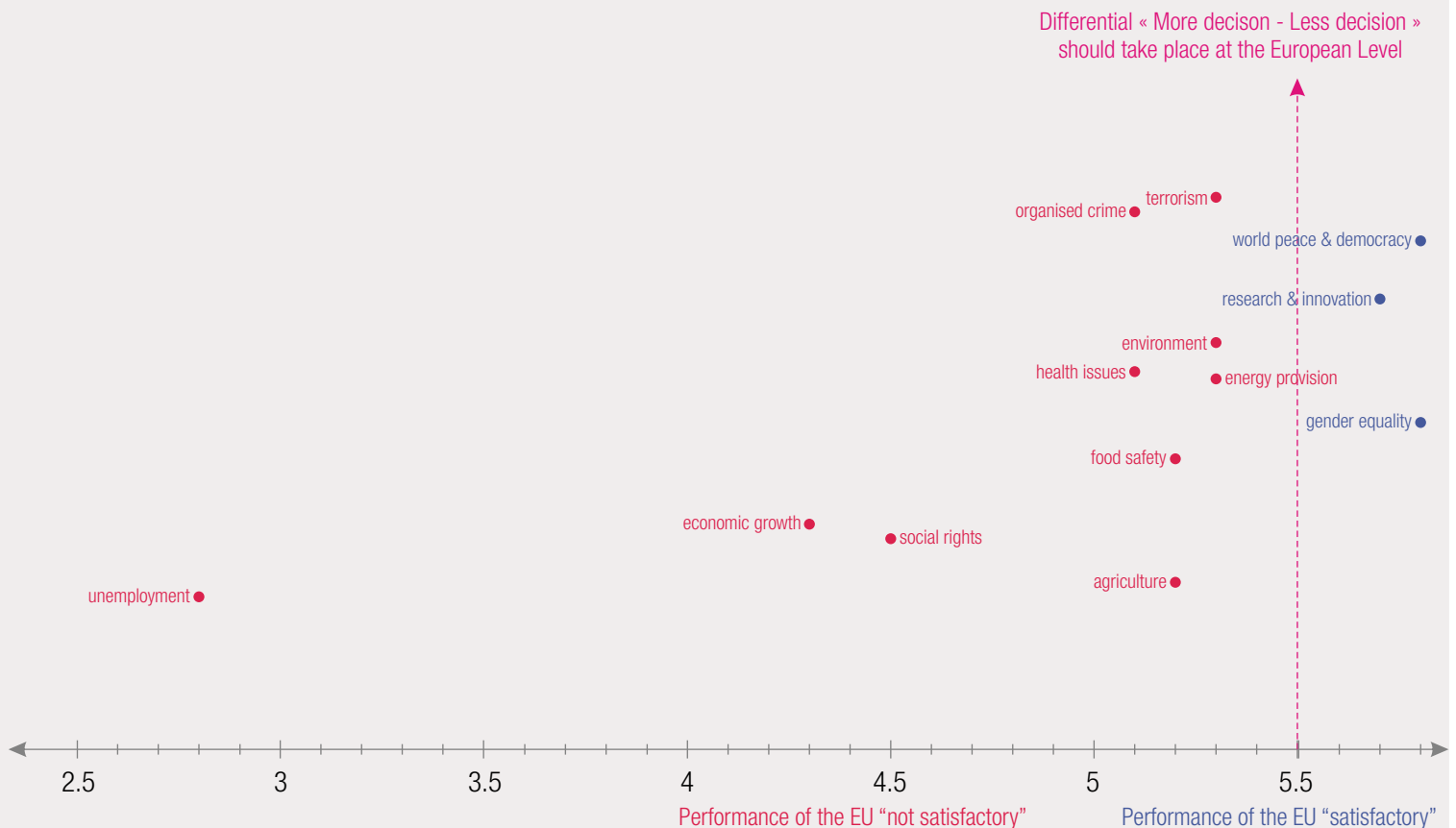
