



Spontaneous Mentions of the Words 'European Union'


QUESTION: When you hear the words "European Union", what comes to your mind first? (Open-ended question - Spontaneous answers)



Main Achievements of the European Union


QUESTION: Which of the following do you think is the most positive result of European unification? And the second most positive result?





Harmonization of Social Welfare Systems in the European Union








Attitudes Towards Globalisation


