



# Spontaneous Mentions of the Words 'European Union'


QUESTION: When you hear the words "European Union", what comes to your mind first? (Open-ended question - Spontaneous answers)



Main Achievements of the European Union


QUESTION: Which of the following do you think is the most positive result of European unification? And the second most positive result?





Most Helpful Thing for the Future of Europe


QUESTION: Which of the following would you consider to be most helpful if anything, for the future of Europe?







How to Strengthen European Identity?



#### Attitudes Towards Enlargement


QUESTION: Could you tell me to what extent you agree or disagree with each of the following statements.





Harmonization of Social Welfare Systems in the European Union








## Attitudes Towards Globalisation


