



Membership of the European Union


QUESTION: Generally speaking, do you think that (OUR COUNTRY)'s membership of the European Union is...?





Spontaneous Mentions of the Words 'European Union'


QUESTION: When you hear the words "European Union", what comes to your mind first? (Open-ended question - Spontaneous answers)




QUESTION: Which of the following do you think is the most positive result of European unification? And the second most positive result?





Most Helpful Thing for the Future of Europe


QUESTION: Which of the following would you consider to be most helpful if anything, for the future of Europe?







How to Strengthen European Identity?





Harmonization of Social Welfare Systems in the European Union








Attitudes Towards Globalisation

QUESTION: Which of the following two propositions is the one which is closest to your opinion with regard to globalisation?








